



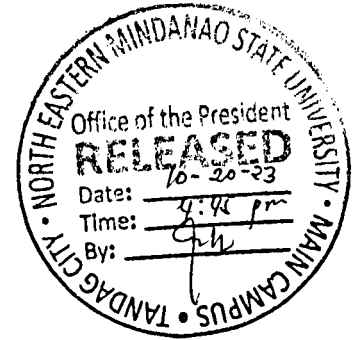



Your participation in this assembly is crucial, as we will be discussing and deciding on matters that significantly impact our Faculty Union. The two main agenda items for this assembly are as follows:


- 1. Amendment and Ratification of the Constitution and By-Laws**
