In view of the upcoming budget deliberations for State Universities and Colleges (SUCs) in the House of Representatives and the Senate, the Philippine Association of State Universities and Colleges (PASUC) has issued an urgent request for the submission of the status of infrastructure projects funded under Special Provision No. 5 of the General Appropriations Act (GAA) for FY 2024.

To ensure the accuracy and completeness of the data, each State University and College (SUC) is required to submit only one consolidated response. As such, the Planning Officer III is hereby designated as the Focal Person responsible for coordinating with the respective offices and campuses to gather and verify the necessary information.

The designated Focal Person is required to submit the consolidated report using the Online Survey Form provided by PASUC, which can be accessed through the following link: https://forms.gle/DbPGMZM94kJrZbLY6. The submission deadline is set for 5:00 PM on Thursday, August 22, 2024.
