- **March 4, 6, 2025** 8:30 AM - 11:30 AM

These rehearsals involve collaborative performances among the **Dance Troupe, Choir, and Band Members**, requiring ample time to ensure synchronization and preparation. The objective is to provide a **meaningful and well-executed State of the University Address**, which will be attended by the **Members of the Board of Regents and Heads of Partner Agencies**.

Advisers/Trainers of the performing arts groups of Tandag Campus shall be responsible for identifying the students involved in the rehearsals until the event day.

The **Campus Director of Tandag** shall monitor compliance and report any faculty member or personnel who does not adhere to this directive.

The **Campus Director, OSWD Director, Culture and Arts Director, and the Executive Assistant III (Protocol Officer for Special Events)** shall have **oversight functions** over the rehearsals to ensure their efficiency and success.
