
In compliance with this directive and to ensure **data accuracy and timely submission**, the following actions are hereby undertaken:


- The University Registrar shall serve as the Focal Person responsible for gathering, verifying, and consolidating the required data from all campuses. Campus Registrars shall coordinate closely with the University Registrar for submission.
- 2. Campus Directors must ensure that their respective registrars provide accurate admission and enrollment data. The **Planning Unit** and **Finance Units** shall provide relevant supporting information for budgetary considerations.
- 3. All consolidated data must be submitted to the Office of the University Registrar no later than 12:00 NN on March 12, 2025 for final validation and transmission to PASUC on or before March 13, 2025, at 3:00 PM.
- 4. The Focal Person shall submit the final report using the **PASUC Online Survey** Form via this link: https://forms.gle/mC7BwnE6D98QrHoJ9.

Given the urgency of this matter, all concerned offices are directed to prioritize this task and ensure full compliance. Non-submission or delays may impact NEMSU's funding allocation and institutional planning for future enrollments.
