

SUBJECT : PREPARATION OF NEMSU FOR THE 2025 TIMES HIGHER EDUCATION (THE) IMPACT RANKINGS APPLICATION



In line with the University's vision to contribute to sustainable development and global academic visibility, the University is preparing for its application to the **2025 Times Higher Education (THE) Impact Rankings**, which assess universities against the United Nations Sustainable Development Goals (SDGs).

To ensure a comprehensive and well-documented submission, all concerned offices and officials are hereby instructed to take part in the preparation, collection, and uploading of data and evidences for the 17 SDGs, covering the period **January to December 2024**.

I. NEMSU Sustainability Policy

Lead Office : **OVRIE**, in coordination with the **RDE Division**

II. Website In-Charge

Lead Unit: ICT Unit

Scope: Development of a dedicated THE Impact Rankings webpage on the official NEMSU website. This includes the proper uploading of validated documentary evidences and organizing content by SDG. To support this, a Web Developer will be assigned to assist with layout design, formatting, and systematic uploading of files to ensure consistency and accessibility.

III. Research and Data Management Support

To further facilitate efficient data consolidation and report writing, Research Assistants will be designated under the OVRIE to assist the SDG Chairs and Task Groups in:

- Gathering and organizing relevant documents
- Verifying and categorizing evidences
- Assisting in the packaging of narrative and statistical reports
- Coordinating with units for follow-up submissions


